CORPORATION EASEMENT

The location of all such water pipes, lines and other EDGARTOWN WATER DEPARTMENT fixtures is to be determined and fixed by the Grantee herein when and as actually laid hereunder.

This easement includes the right to enter upon said way or ways for the purpose of inspecting and repairing the water facilities and the right to open, dig up, and reopen said way or ways from time to time for the purpose hereof, the Grantee to restore the surface of said way or ways as nearly as reasonable may be to the same condition as the way or ways were at the time of opening or reopening thereof.
